Bylaws on the council's role and work

- See article 15 of the <u>Efling bylaws</u>
- Union's highest authority between general meetings
- Manned by 115 general members and 15 board members = 130
- Board may appoint substitutes when members can't attend
- 2-year term (starts on January 1 in odd-numbered years)
- Elects other union subcommittees
- Monthly meetings in the winter (October-May)
- Should reflect the union (sectors etc)
- Chairman chairs meetings

Who is on the council?

- Active members with experience of or interest in the union's work
- List is prepared by a selection committee looks at composition and groups (gender, age, origin, region, sector, public/private etc)
- (Alternative lists may be presented but normally no opposing list)
- Substitutes may be appointed in place of those who quit
- Remember: Supreme authority in union affairs!
- (Council of delegates is not a council of union reps although many members are reps and vice versa)

Customary procedures

- Meetings held on Thursdays on the 4th floor in Guðrúnartún
- Hot food in the 3rd floor canteen
- Chairman, board and staff prepare meetings
- Usually deal with policy and struggles of the union, rather than operations
- Meetings are held according to a meeting schedule
- Attendance list is kept
- Since 2018 all meetings have been interpreted by text
- Minutes are kept and translated to English
- Fall concludes with a Christmas meeting and a Christmas present

Revival of the council

- Fall 2020: new procedures to improve activity in the council
- The board takes more time to prepare and participate in meetings

 has permission to decide topics and invite guests from the
 membership
- Staff call invitees and are present at meetings to assist
- Quality lectures + discussion
- Meeting product e.g. resolution for public distribution
- Union dues repaid at working year's end in proportion to attendance (see regulation sent via email on January 12, 2021)
- Improvements to the 4th floor have begun!

Rules of order

- Only council members have voting rights at meetings
- Majority of attending members decides
- All council members may speak with the chair's permission
- List of speakers used
- Any issue may be taken up under "Other matters"

Covid-19 pandemic

- October 15: First online meeting of the council
- Zoom app used both for lectures and group discussion
- Meetings start at 7:30pm, maximum 2 hours
- Text-translation via the CC button
- Buttons for voting
- HAS GONE BETTER THAN COULD BE HOPED!
- Meetings will remain online until restrictions on gatherings are lessened – the council has 130 members!
